

**Official Rules**  
**“Crew Cover Up Sweepstakes”**  
**Sponsored by VH1**

1. NO PURCHASE NECESSARY TO ENTER OR WIN THE GRAND PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE OF THE FORTY-EIGHT CONTIGUOUS UNITED STATES AND THE DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW. A TWITTER OR INSTAGRAM ACCOUNT AND INTERNET CONNECTION ARE REQUIRED FOR ENTRY.

2. **Sweepstakes Overview and Entry Period:** The “Crew Cover Up Sweepstakes” (the “Sweepstakes”) commences at 9:00:00 PM Eastern Daylight Time (“EDT”) on September 19, 2018 and ends at 11:59:59 AM (EDT) on October 11, 2018 (the “Sweepstakes Period”). All entries must be received by 11:59:59 AM (EDT) on October 11, 2018. Entrants will have the opportunity to enter by submitting an image of a undesirable tattoo which he/she would like to have covered up or reworked (as further set forth in Section 4 below. Images will be aggregated on a microsite for viewing and voting by the public to determine the one (1) Grand Prize Winner (hereinafter defined).

3. **Eligibility:** This Sweepstakes is open to legal residents of the forty-eight (48) contiguous United States and District of Columbia who are at least eighteen (18) years of age or older at the time of entry and deemed to be of the age of majority in his/her state of legal residence. Any entrant who is at least eighteen (18) years of age but deemed to be a minor in his/her jurisdiction of residence (“Minor”) is not eligible to participate or win a prize. Employees and their immediate families (*i.e.*, parents, spouse, children, siblings, grandparents, step parents, step children and step siblings) of Viacom Media Networks, a division of Viacom International Inc. (“VMN” or “Sponsor”), and Twitter Inc. (“Twitter”), Facebook, Inc., on behalf of the Instagram services (“Facebook”) and each of their parent companies, subsidiaries and other affiliated companies, sponsors, advertising agencies and third party fulfillment agencies and their respective agents, employees, officers, directors, successors and assigns (collectively, the “Sweepstakes Entities”) are not eligible to enter the Sweepstakes. By participating in this Sweepstakes, entrants: (a) agree to be bound by these Official Rules and by the interpretations of these Official Rules by Sponsor, and by the decisions of Sponsor, which are final in all matters relating to this Sweepstakes; (b) release and hold harmless the Sweepstakes Entities against any and all claims, injury or damage arising out of or relating to participation in this Sweepstakes and/or use or misuse or redemption of the Grand Prize (as hereinafter defined) and (c) acknowledge compliance with these Official Rules.

4. **To Enter:** During the Sweepstakes Period, entrants will be asked to “tweet”, “share” or “post” an original photo or video depicting his/her tattoo which he/she wishes to have reworked (the “Photo”) and include the hashtags #BICCoverUp and #Sweepstakes (the “Contest Hashtags”) to count as one (1) “Entry”. Entries which are submitted without the two (2) Sweepstakes hashtags and/or which have an incomplete additional entry form will be disqualified. Submission of an Entry with the Sweepstakes Hashtags constitutes entrant’s acceptance of these Official Rules. Entrants must complete their Entries as directed and within the timeframe specified by Sponsor. The failure of an entrant to comply with the foregoing may result in an incomplete or disqualified Entry. Sponsor has the sole discretion to determine whether a submission qualifies as an Entry. All Entries submitted in accordance with these Official Rules shall be hereinafter referred to as “Eligible Entries”. At Sponsor’s option, Entries may be featured online in a gallery on VH1.com and/or on the *Black Ink Crew* Facebook, Twitter or Instagram accounts.

Entries submitting via Instagram must be submitted in accordance with the Instagram Terms of Use (<http://instagram.com/about/legal/terms/>) and Entries submitted via Twitter must be submitted in accordance with Twitter’s Terms of Service (<https://twitter.com/tos>). Your Instagram and Twitter account privacy settings must be set to

“Off” or your Entries may not be visible to Sponsor and may not thus be received. If you do not have an Instagram account, visit <http://www.instagram.com>. If you do not have a Twitter account, visit <http://www.twitter.com>. Registration for Instagram requires downloading the free applications to your mobile device and following the on-screen instructions to create a new account. The Instagram app is available for download from [iTunes](#) or directly from the App Store on your iPhone, iPod touch, or iPad or from the Google Play store on your Android device. The Twitter app is available for download on your mobile device by visiting <https://twitter.com/download>.

The potential Grand Prize Winner (hereinafter defined) may be required to show proof of being the authorized account holder of the Twitter or Instagram account associated with the Entry. In the event of a dispute over who submitted a winning Entry, the authorized subscriber of the Twitter/Instagram account used to participate in the Sweepstakes at the actual time of entry will be deemed to be the entrant. The authorized account subscriber is defined as the natural person who is assigned a Twitter account by Twitter or an Instagram account by Instagram. By entering this Sweepstakes, you agree that you are solely responsible for all data charges that you may incur. All such charges are billed by and payable to your mobile service provider. All Entries become the property of Sponsor who shall have the right to edit, adapt, and publish any or all of the Entries. Entries will not be acknowledged or returned.

PLEASE NOTE THAT ANY AND PHOTOS AND METADATA SUBMITTED FOR THIS SWEEPSTAKES MAY BE PUBLICLY VIEWABLE. IN ADDITION, ENTRANTS ACKNOWLEDGE THAT THEIR ENTRIES MAY BE RETWEETED OR REPOSTED BY THE PUBLIC OR OPEN TO PUBLIC COMMENTARY, FOR WHICH SPONSOR SHALL NOT BE LIABLE.

Entrant agrees: (a) that he/she has all rights to the contents of the Entry and all components thereof, and that Entrant has obtained all rights, consents and permissions, necessary to grant the rights granted herein; (b) that the Entry does not and will not violate any law, statute, ordinance or regulation; (c) that the Entry is free and clear of any liens or claims with respect to the use of the Entry in the manner authorized herein and will not give rise to any claims of infringement, invasion of privacy or publicity, infringe on any rights or interests of any third party, or give rise to any claims for any payment whatsoever, including but not limited to claims for re-use fees or residuals; and (d) that the Entry is not and will not be defamatory, trade libelous, pornographic or obscene.

Entrant shall retain all copyright in and to his/her Entry; provided, however that entrant agrees that by entering into this Sweepstakes he/she is granting Sponsor (and its subsidiaries and affiliates and affiliated broadcast stations and networks, successors and assignees and licensees) the non-exclusive, worldwide irrevocable right and license, but not the obligation, to exhibit, broadcast, copy, reproduce, encode, compress, encrypt, incorporate data into, edit, dub, superimpose, rebroadcast, transmit, record, publicly perform, distribute, and synchronize in timed relation to visual elements, the Entries and/or any portions or excerpts thereof, in any manner, an unlimited number of times, in any and all media, now known or hereafter devised for any purpose, throughout the world in perpetuity. Sponsor may use the Entries (or any portion thereof, including, without limitation an entrant’s, Twitter and/or Instagram screen name) to advertise, promote and publicize, the Sweepstakes, Sponsor’s business, products and worldwide programming services and/or Sponsor’s websites in all media throughout the universe and may authorize others to do so; such advertising, promotion and publicity may include portions and excerpts, in addition to cut-in, synchronized, dubbed and superimposed versions of the Entries. Entrant acknowledges that Sponsor may use the Entries in accordance with the permissions granted herein without any payment to the undersigned or any third party.

Entrants agree that Entries **shall not** contain, include or involve any of the following:

- Illegal (*e.g.*, discriminatory, harassing) or inappropriate activity, behavior or conduct (*e.g.*, inflicting emotional distress)
- Conduct or activities in violation of these Official Rules
- Any other content, display, materials and/or images that is or could be considered inappropriate, unsuitable, or offensive, as determined by Sponsor in its sole discretion
- Any minor or person appearing recognizably other than the entrant

Language and themes contained in Entries will be evaluated by Sponsor based on content and societal acceptability.

Sponsor is not obligated to, use, publish, display or broadcast any submitted Entries (in whole or in part). Each entrant acknowledges that Sponsor will rely on such entrant's agreement and compliance with these Official Rules when entrant submits or attempts to submit the Entry. Sponsor reserves the right to reject any Entries that it deems, in its sole discretion, to violate any of its standards and practices policies or the terms and conditions set forth in these Official Rules. Sponsor may modify or edit any materials related to an Entry or request entrants to do so, so that such materials meet such guidelines.

In submitting an Entry into this Contest, each entrant agrees to, confirms and represents to Sponsor that neither he/she nor anyone else has engaged or taken part in (or induced or encouraged anyone else to do so) in any activity or conduct in connection with this Sweepstakes that: (i) may or is likely to harm or create a risk of harm, physical or mental injury, emotional distress, death, disability, disfigurement, or physical or mental illness to any person, other living thing or any property; (ii) may/or is likely to create a risk of any other loss or damage to person, living things or property; (iii) is or may constitute a crime, unlawful or non-consensual activities (*e.g.*, conduct that could lead to criminal prosecution), tortuous conduct (*e.g.*, conduct that could lead to civil prosecution) or the violation or infringement of the rights of any other party; or (iv) violates any of the terms or conditions of these Official Rules.

5. **Voting to Determine the Grand Prize Winner:** Eligible Entries will be aggregated on a microsite at <http://BICCoverup.VH1.com> on an on-going basis as received for public viewing throughout the Sweepstakes Period. Visitors to the microsite will have the option to vote "Keep It" or "Cover It". At the conclusion of the Sweepstakes Period, the entrant with the highest number of "Cover It" votes will be declared the provisional "Grand Prize Winner" (the "Grand Prize Winner"), subject to the conditions set forth herein. Once the provisional Grand Prize Winner has confirmed eligibility to the satisfaction of Sponsor, such provisional Grand Prize Winner will be deemed to be the Grand Prize Winner. Sponsor reserves the right to modify or cancel the Sweepstakes if there is an insufficient number of qualifying Entries received or to select the Grand Prize in the event of a technical delay or malfunction of the public voting process or if the public voting process is suspected or found to have been tampered with in any way. In the event that the public voting process is interrupted for any reason, Sponsor reserves the right to determine the Grand Prize Winner, who shall be selected at random from among all Eligible Entries received. Entrants are prohibited from obtaining votes by any fraudulent or inappropriate means, including, without limitation, offering prizes or other inducements to members of the public, as determined by Sponsor in its sole discretion. To the extent permitted by law, the Sweepstakes Entities disclaim any liability from, and all Entrants, (whether or not the Grand Prize Winner), agree to waive, any claims against the Sweepstakes Entities relating to the voting, winner selection or awarding process. Sponsor reserves the right to delay the announcement of the Grand Prize Winner in its sole discretion. Limit one (1) vote per person per Entry.

6. **Grand Prize Winner's Selection/Notification:** The Grand Prize Winner will be announced on or around October 11, 2018. Sponsor will attempt to make contact with the potential Grand Prize Winner over the seventy-two (72) hour period following the potential Grand Prize Winner's selection via the email address or phone number provided on the potential Grand Prize Winner's entry form. If a potential Grand Prize Winner cannot be reached directly during the seventy-two (72) hour period in which he/she is being contacted, such potential Grand Prize Winner will be disqualified and an alternate Grand Prize Winner will be selected from among the remaining applicable Eligible Entries received. This process will be repeated until a potential Grand Prize Winner responds, as time permits, in Sponsor's sole discretion.

7. **Grand Prize Winner's Verification:** The potential Grand Prize Winner must prove eligibility, including, without limitation, proof of age and residence, social security or resident alien identification number, within three (3) days of being notified as the potential Grand Prize Winner. In the event of non-compliance by the potential Grand Prize Winner, such potential Grand Prize Winner shall be disqualified and all privileges otherwise due as the Grand Prize Winner shall be terminated and an alternate potential Grand Prize Winner may be chosen from among all of the remaining Eligible Entries received, if time permits, in Sponsor's sole discretion. Grand Prize Winner must sign within three (3) days of receipt of such documents from Sponsor: (a) an affidavit of eligibility and release of each of the Sweepstakes Entities from any and all liability, loss, claims, demands, and causes of action for personal injury and/or damage, theft, loss, or any other harm suffered in connection with this Sweepstakes and (b) except where prohibited, a promotional release granting Sponsor the right to use their name and likeness, signature, voice and biography for advertising and publicity purpose without additional compensation. Grand Prize Winner agrees to the foregoing and in addition Grand Prize Winner agrees to obtain, upon request of Sponsor any additional documentation and releases necessary to prove his/her unrestricted ownership in all materials contained in his/her Entry and Sponsor's right to use such Entry, in whole or in part, without limitation in all media and for any purpose whatsoever without compensation or further obligation to the Grand Prize Winner. Entry into this Sweepstakes constitutes entrant's agreement to sign such releases. In addition, if selected as the Grand Prize Winner, Entrant must also complete any additional legal documents provided by Sponsor (or third party on its behalf, if applicable) with respect to the Grand Prize awarded and return them as instructed within the time frame specified by Sponsor or Grand Prize Winner may forfeit the prize at Sponsor's sole discretion. Sponsor expressly reserves the right to delay the announcement of the Grand Prize Winner for creative or technical reasons or

for any other reason Sponsor deems necessary. The affidavit of eligibility provided prior to the receipt of the Grand Prize must be complete and must include Grand Prize Winner's social security or resident alien identification number.

**8. Grand Prize (1):** The Grand Prize Winner will receive a trip for one to New York City to visit the Black Ink Crew tattoo shop and receive one (1) tattoo consultation and one (1) tattoo session (up to six (6) hours of services) at a to-be-determined date in January 2019. The trip includes: (a) round-trip coach airfare for Grand Prize Winner between a gateway airport in the forty-eight (48) contiguous United States nearest Winner's primary residence and a major airport nearest New York, NY (if Grand Prize Winner resides within a one hundred fifty (150) mile radius of New York, NY, airfare for Winner will be replaced with ground transportation); (b) two (2) night hotel accommodations at a hotel to be determined by Sponsor (which includes one [1] standard room, room and tax only) (the "**Hotel**") and (c) an arranged visit to the Black Ink tattoo shop for one (1) tattoo consultation, and one (1) tattoo session (collectively, the "**Grand Prize**").

Prize fulfillment is subject to availability of services. Prize is only redeemable within the forty-eight (48) contiguous United States. The Grand Prize may not be sold, traded, transferred, refunded, commissioned or redeemed for cash value elements and may not be substituted by Grand Prize Winner. Grand Prize Winner is responsible for: travel insurance; local and long distance telephone calls; meals and beverages (other than as expressly set forth in these Official Rules); communications including internet; merchandise and souvenirs; incidental expenses; additional tips and gratuities; income and other taxes; transportation (other than as expressly set forth in these Official Rules); and all other costs and expenses not otherwise mentioned herein.

Sponsor is not responsible if Grand Prize Winner is unable or unavailable to accept the Grand Prize.

The approximate retail value ("**ARV**") of the Grand Prize is \$2,450.00, however, the ARV is subject to change based on current market conditions at time of prize fulfillment. Any difference between the ARV and the actual value, if any, will not be awarded. The Grand Prize is not transferable or refundable and must be accepted as awarded. **9. General Prize Terms:** Arrangements for fulfillment of the Grand Prize will be made by Sponsor. The value of the Grand Prize may be taxable to the Winner as income. Grand Prize Winner may need to supply Sponsor with his/her social security numbers for tax purposes. An IRS Form 1099 may be issued in the name of the Grand Prize Winner for the actual value of the Prize received. Upon entry into the Sweepstakes, Grand Prize Winner (as well as all other entrants) is/are required to comply with any and all applicable federal, state, and local laws, rules, and regulations. All federal, state and local taxes (if any), and any other costs and expenses associated with the Grand Prize not specifically provided for in these Official Rules, are solely Winner's responsibility. Sponsor shall have no responsibility or obligation to the Grand Prize Winner or any potential Grand Prize Winner who is unable or unavailable to accept or utilize the Grand Prize as described herein.
